MEMBERSHIP AGREEMENT TERMS AND CONDITIONS

PAYMENT - The annual membership dues must be paid in full to commence use of program and are non-refundable.
REFUSAL OF PRIVILEGE - High Bridge Hills Golf Club shall have the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein.
REGISTRATION - All Golf players must register and sign in at the Golf Shop before play. Annual Members are required to show their Member Card (which is non-transferable). Golf play starts from the first tee unless advised otherwise by the Golf Shop.
HOLIDAYS - High Bridge Hills Golf Club recognizes the following holidays: Memorial Day, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving, New Year's Day. Weekend rates apply to these days. The facility is closed on Christmas Day.
GOLF STARTING TIMES - Starting times may be obtained via the Internet at www.highbridgehills.com or by calling the Golf Shop at 908.638.5055. These are available up to 10 days in advance and are recommended so we may avoid any inconvenience on the day of play. In order to provide the maximum tee time availability to all Annual Members, please extend the courtesy and call the Golf Shop if you are not going to use a reserved tee time. Annual Members without reserved times will be subject to availability.
TEE TIME RESERVATIONS - Cancellation Policy - Each Annual Member has the capability of reserving tee times up to 10 days in advance. High Bridge Hills Golf Club reserves the right to pair all twosomes and threesomes. When reserving tee times, Annual Members are responsible for the number of players booked. High Bridge Hills Golf Club has implemented a 24-hour cancellation policy. Annual Members are responsible for calling the Golf Shop with any changes to tee times. Annual Members who short show or no show will be subject to a no show charge for each player. Groups that habitually no-show will be subject to member suspension. No groups are permitted to have more than four players per tee time.
DRESS CODE - Golfers are expected to wear traditional golf attire on the course. High Bridge Hills Golf Club is a non-metal spike facility.

PACE OF PLAY - All Annual Members are expected to abide by the pace of play policies instituted by the General Manager. Players are expected to play in 4 hours and 30 minutes or less.
COURTEOUS PLAY - It is golfing etiquette to replace divots, repair ball marks on greens, rake smooth all marks made in sand traps and remove used tees from the teeing grounds. Please assist us in the upkeep of the course and encourage your guests to do likewise.
GOLF CARTS - Cart rules will be posted daily in the Golf Shop and all players are expected to abide by these rules. Carts must be driven on cart paths only on all Par 3's and Hole 16, and kept at least 20 feet from all Tees and Greens at all times. Roped off areas are off limits to carts. Players must pair up on carts. No single carts will be permitted in twosome or foursomes.
USGA GHIN HANDICAP - All High Bridge Hills Golf Club Annual Members are eligible for a handicap. See a member of our professional staff to setup your GHIN handicap. Players that do not have a valid and active USGA Ghin Handicap will be ineligible to compete in Net competitions.
FOOD & BEVERAGE - Food and beverages are not permitted on the course unless purchased from High Bridge Hills Golf Club. Food and Beverages may be purchased from the High Bridge Hills Grille or the beverage cart on the golf course. Private coolers are not permitted. Players will be refused play and the privileges will be lost if any policies stated herein are not adhered to.
LIMITATION OF LIABILITY - High Bridge Hills Golf Club will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if High Bridge Hills Golf Club has been advised of the possibility of such damages. In no event shall the total cumulative liability of High Bridge Hills Golf Club in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to High Bridge Hills Golf Club under this Agreement.
