ROCK MANOR MEMBERSHIP AGREEMENT TERMS & CONDITIONS

PAYMENT – Membership fees must be paid in full to receive privileges.

PARTICIPATING COURSES – Participating courses to which you will receive member benefits are Rock Manor, Ed Oliver, and Delcastle. This list of courses is subject to change at any time.

REFUSAL OF PRIVILEGE – Any participating course has the right to refuse golf course or other privileges to anyone who is deemed to be in violation of this agreement and/or the course’s rules.

TEE TIMES – Tee times may be obtained up to 10 days in advance over the phone or in person at the Golf Shop. Those reserving tee times are responsible for checking-in with the number of players booked. Please extend the courtesy of calling in advance to cancel your tee time or to report a lower number of players. Members who short show or no show regularly are subject to no show charges and/or the loss of advance booking privileges. It is the Member’s responsibility to check-in with the Golf Shop prior to accessing the course.

MEMBER PRIVILEGES – Member privileges include golf, and cart (if cart is included in the membership option selected), during membership privilege hours. Additional privileges include 10 day advance tee times, 10% off guest fees (for up to 3 guests), 10% off merchandise (excluding sale and special order), 10% off non-packaged food, DSGA Handicap, discounted rate for special events and range balls. The Member’s visiting course privileges include golf benefits and/or discounted rates as outlined in membership collateral and on the course’s website. All privileges are subject to change and expire 365 days from purchase.

LIMITATION OF LIABILITY – Each participating course will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the member or his/her guests arising out of or related to this Agreement even if the participating course has been advised of the possibility of such damages.
