## WINTONBURY HILLS GENERAL PASSHOLDER AGREEMENT TERMS AND CONDITIONS

**DEPOSIT** - Confirmation of annual pass will occur only upon signed receipt of this Agreement and a 50% deposit of the total annual dues.

**PAYMENT** - Annual pass must be paid in full.

**REFUSAL OF PRIVILEGE** - Wintonbury Hills has the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein.

**REGISTRATION** - All players must register and sign in at the Golf Shop before play. Passholders are required to show their Annual Pass Card (which is nontransferable). Golf play starts from the first tee unless advised otherwise by the Golf Shop.

**HOLIDAYS** - Wintonbury Hills recognizes the following holidays: Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving. Weekend rates apply to these days.

**GOLF STARTING TIMES** - Starting times may be obtained via the Internet at wintonburyhills.com or by calling the Golf Shop at 860.242.1401. These are available up to 10 days in advance and are recommended to avoid any inconvenience on the day of play. In order to provide the maximum tee time availability to all annual passholders, please extend the courtesy and call the Golf Shop if you are not going to use a reserved tee time. Annual Passholder without reserved times will be subject to availability. In an effort to eliminate delays due to lack of daylight, starting September 1, all weekend tee times will begin 1/2 hour later than scheduled. This will allow the earlier groups to tee off at first daylight, without further delaying those annual passholder with later tee times.

**TEE TIME RESERVATIONS-CANCELLATION POLICY** - Each passholder has the capability of reserving tee times up to 10 days in advance. Wintonbury Hills reserves the right to pair all twosomes and threesomes. When reserving tee times, annual passholders are responsible for the number of players booked. Wintonbury Hills has implemented a 24-hour cancellation policy. Annual passholders are responsible for calling the Golf Shop with any changes to tee times. Annual passholders who short show or no show will be subject to a no show charge for each player. The charge will be posted to the account of the annual passholder who made the tee time. Groups that habitually no show will be subject to annual pass suspension. No groups are permitted to have more than four players per tee time.

**GUEST PLAY** - Annual Passholders are welcome to bring guests. Any accompanied guest will receive a discount on green fees.

**DRESS CODE** - Golfers are expected to wear traditional golf attire on the course. Golf shoes and a collared shirt are required. Jeans are not acceptable. Wintonbury Hills is a non-metal spike facility.

**PACE OF PLAY** - All annual passholder are expected to abide by the pace of play policies instituted by the Head Golf Professional. Players are expected to play in 4 hours and 30 minutes or less. (Pace of Play Policy is enclosed.)

**COURTEOUS PLAY** - It is golfing etiquette to replace divots, repair ball marks on greens, rake and smooth all marks made in sand traps and remove used tees from the teeing grounds. Please assist us in the upkeep of the course.

**GOLF CARTS** - Cart rules will be posted daily on the first tee and all players are expected to abide by these rules. Carts must be driven on cart paths on all Par 3's and kept at least 20 feet from all Tees and Greens at all times. Roped off areas are off limits to carts. Players must pair up on carts. **No single carts will be permitted in twosomes or foursomes.**

**FOOD & BEVERAGE** - Food and beverages are not permitted on the course unless purchased by Wintonbury Hills. Cases or six-packs of soda and beer and ice may be purchased from the restaurant or the beverage cart on the golf course. Private coolers are not permitted. Players will be refused play and the privileges will be lost if any policies stated herein are not adhered to.

**BEVERAGE CART** - Only Wintonbury Hills employees will be permitted to drive and serve on beverage carts.

**LIMITATION OF LIABILITY** - Wintonbury Hills will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if Wintonbury Hills has been advised of the possibility of such damages. In no event shall the total cumulative liability of Wintonbury Hills in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to Wintonbury Hills under this Agreement.

ANY ABUSE OF COURSE POLICY INCLUDING TAMPERING WITH GPS IS A VIOLATION OF TERMS AND CONDITIONS AND IS SUBJECT TO TERMINATION OF PASSHOLDER RIGHT OF ADMISSION.
