TERMS AND CONDITIONS

MONTHLY PAYMENTS

Upon joining, the first monthly fee will be charged. The amount will be \$50 if joining on the 1st of the month or a prorated amount if joining between the 2nd and last day of the month. A \$50 fee will be charged to your credit or debit card each month thereafter until you cancel, or the program ends. Your credit or debit card information will be held in a secure, online environment. If a monthly charge fails to go through benefits will be suspended immediately, and to reinstate a membership all past due monthly charges must be paid.

GREENS FEES

You will pay a \$20 greens fee for each 9 or 18-hole round at Prince William Golf Course or Forest Greens Golf Club any day of the week at any time – no restrictions. This fee applies whether you walk or ride. Replay rounds will be charged at the same \$20 rate or the prevailing replay rate, whichever is lowest.

Half price player's fee during the months of December, January, and February.

CANCELLATION

Written notice is required to cancel the membership and can be submitted at any time by emailing memberships@princewilliamgolfclub.com or memberships@forestgreens.com. **You must provide an email to join the membership, and the written cancellation must come from the email provided at joining. Upon receipt of written notice to cancel, there will be one final \$50 charge and 30-day period of benefits. Prince William Golf Course and/or Forest Greens Golf Club may cancel this program at any time.**

LIMITATION OF LIABILITY

Prince William Golf Course and/or Forest Greens Golf Club will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if Prince William Golf Course and/or Forest Greens Golf Club has been advised of the possibility of such damages. In no event shall the total cumulative liability of Prince William Golf Course and/or Forest Greens Golf Club in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to Prince William Golf Course and/or Forest Greens Golf Club under this Agreement.

ASSUMPTION OF RISKS AND INDEMNIFICATION

In consideration for the privilege of using the Prince William Golf Course and/or Forest Greens Golf Club Facilities, each person entering upon or using the Prince William Golf Course and/or Forest Greens Golf Club Facilities agrees:

(a) to accept all risks associated with the use of the Prince William Golf Course and/or Forest Greens Golf Club Facilities and to release their employees, agents, officers, Directors, Successors, and Assigns from and indemnify and defend the Prince William Golf Course and/or Forest Greens Golf Club against any and all claims, whether or not based on the acts or omissions of the Prince William Golf Course and/or Forest Greens Golf Club, arising out of or in any way connected with such use of the Prince William Golf Course and/or Forest Greens Golf Club Facilities to the fullest extent allowed by law; and (b) to assume sole responsibility for their personal safety and the safety of their personal property brought upon, used or stored at the Prince William Golf Course and/or Forest Greens Golf Club Facilities; the Prince William Golf Course and/or Forest Greens Golf Club shall not be responsible for any loss or damage to any personal property brought upon, used or stored at the Club Facilities, whether in lockers or elsewhere; and (c) Each Member and Member's designee further agrees to be responsible and liable for any property damage and/or personal injury which such Member or designee causes, or which is caused by such Member's or designee's authorized users or guests.

REFUSAL OF PRIVILEGE

Prince William Golf Course and/or Forest Greens Golf Club shall have the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein.
