PAYMENT – Membership fees must be paid in full to receive privileges.

TEE TIMES – Tee times may be obtained up to 10 days in advance via the Internet, over the phone or in person at the Golf Shop. Those reserving tee times are responsible for checking-in with the number of players booked. Please extend the courtesy of calling in advance to cancel your tee time or to report a lower number of players. Members who short show or no show regularly are subject to no show charges and/or the loss of advance booking privileges. It is the Member's responsibility to check-in with the Golf Shop prior to accessing the course.

MEMBER PRIVILEGES – The Member's home course privileges include golf and cart (if cart is included in the membership option selected) during membership privilege hours. Additional privileges include 10 day advance tee times, 10% off guest fees (for up to 3 guests), 10% off merchandise (excluding sale and special order), 10% off non-packaged food, DSGA Handicap, and discounted rate for special events.
