Limited to only 50 Memberships and open to individuals under the age of 50 as of 9/1/18, this membership includes unlimited golf, 10-day advance tee times, Member Charging Privileges, 10% off all full priced items in the Golf Shop and Restaurant, and four (4) Guest Passes. Membership Dues/Fees are payable in quarterly installments on 9/1/18, 12/1/18, 3/1/19, and 6/1/19. These memberships may not be renewed for the membership year following the member's 50th birthday - members then must move to either Shareholder or Full Memberships. Members will choose either an Annual Trail Pass or Annual Cart Pass.
