**Tournament Rules**

1. Any special course set up conditions must be requested 10 days in advance.
2. Tee times will be \_\_\_\_\_ minutes, beginning at the time as approved in this agreement.
3. Unless authorized by The Grill at Broken Tee, players or tournament sponsors are ***not permitted to bring their own food or beverages on the course.*** However, special arrangements may be made in advance by calling **The Grill at Broken Tee at 303-781-9328. Please initial \_\_\_\_\_ (indicates you will inform all tournament players).**
4. Golf carts will be rented only to those playing in the tournament unless authorized by the Golf Course Manager.
5. Any damage to golf property shall be repaired/replaced at the expense of the tournament chairperson and/or the individual player.
6. All players will comply with course rules and customary golf etiquette.
7. ***Pace of play policy*** is strictly enforced and groups will be removed for lack of compliance with no refund given. Each group will be expected to complete their round in 4 hours and 30 minutes.
8. If the tournament cannot be played due to bad weather or unplayable course conditions, every effort shall be made to reschedule the tournament. Tournaments are postponed only when the golf course is closed due to unplayable conditions, when conditions preclude the use of golf carts, or when a dangerous condition such as the threat of lightning exists. If inclement weather forces cancellation of play and half of the tournament field has finished 14 holes, no refund will be given.
9. ***A signed contract and deposit are due at time of reservation. Total tournament fee MUST be paid in full 10 days in advance of tournament date or tournament will be cancelled and deposit forfeited. Balance due by \_\_\_\_\_***
10. ***If any tee times are released by the tournament chairperson within 10 days of the tournament, the golf course will open these to the public. Any unsold tee times will be the financial responsibility of the tournament chairperson.***
